In continuation of this office Press Release even number dated ^{1st} September, 2020 and 20th Oct, 2020 regarding applying and submitting of online application forms on National Scholarship Portal(NSP) https://scholarships.gov.in/under the Pre-Matric, Post-Matric and Merit-cum-Means based Minority Scholarship Schemes implemented by the Ministry of Minority Affairs (MoMA), Govt. of India with 100% Central funding for the Session 2020-2021. Under thee Schemes, Scholarships are awarded to the Economically Weaker and Meritorious Students from Centrally notified minority communities viz. Budhist, Christian, Jain, Muslim, Sikh pursing studies in India in a Government or recognized Private Institute/School.

The Central Government has decided to extend the date upto 30th November, 2020 on National Scholarship Portal(NSP) for the year 2020-21, as per the decision of DBT Mission. The registration of fresh and renewal application forms is very slow. A large number of Schools/Institutes have either not applied for the registration or there registration is pending for approval at the level of District Nodal Officers (DNO)/State Nodal Officer (SNO).

Therefore, all Head(s) of the Institutions(s) of Schools/Institutes are directed to complete the verification in time and send it to respective DNO/SNO for verification at L2 level. The Schools/Institutes which are yet to complete the KYC process need to be pursued vigorously by DNO/SNO to complete the process so that no deserving eligible child is left out from the benefit of Scholarship Schemes.
