**Subject:- Filling of Scholarship Applications on National Scholarship Portal for
the Academic Year 2024-25, before 31st October 2024 under Centre or
State Sponsored Scholarship Schemes, reg.**

Sir/ Madam,

On the above cited subject, as you all are aware that:-

1. National Scholarship Portal has been opened to the students on 02-07-2024 for registration and filling of scholarship applications online under centrally or state sponsored scholarship schemes for the Academic Year 2024-25.
2. The last date for filling of scholarship applications under centrally or state sponsored scholarship schemes by the students on National Scholarship Portal is 31-10-2024 for Academic Year 2024-25.
3. Therefore, all the students who want to apply for scholarship under centrally or state sponsored scholarship scheme as per the eligibility of the student(s), are advised to register themselves on the National Scholarship Portal and apply for scholarship according to their eligibility on or before 31-10-2024. Seeding of Bank/ India Post Payment Bank account number is mandatory for transfer of scholarship amount through DBT.
4. The Heads of Institutes within and outside of Himachal Pradesh where Himachali Bonafide students are studying, are requested to provide necessary guidance to the students of their Institute for registration and filling of scholarship applications for the AY 2024-25 online on the portal within the prescribed timeline and no eligible students should be left without scholarship.
5. The Heads of Institutes are also requested to verify all the scholarship applications under centrally and state sponsored scholarship schemes accordingly within the prescribed

timelines. It may be noted that no further extension for registration and filling of scholarship applications by the students and verification of scholarship applications by the Institute will be extended to disburse the scholarship amount well within timeline. The applicants who have followed the timeline will not be allowed to suffer at the cost of defaulters. Therefore, all the eligible students are directed to apply immediately well before 31-10-2024, positively.

6. The Deputy Directors of Higher Education in the State are directed to issue necessary instructions to all the Principals / Headmasters, Govt. and Private Sr. Sec./ High Schools in their District to guide the students and verify all the scholarship applications accordingly at Institute Level (L-1 Level) as well as District Level (L-2 Level) within the prescribed timeline.

This must be given top priority, please.
