In pursuance to Government of India letter No.K-11017/1/2022-SCD-V-Part(1) da ed 14-09-2022, received from the Director, Department of Social Justice & Empowerment, Government of India, New Delhi, the process flow for the registration and verification of documents under Post-Matrie Scholarship Scheme for SC Students and Pre-Matrie Scholarship Schemes for SC & Other Students at Institute level (2-1) will be as under:-

1. At the time of registration on National Scholarship Portal, Aadhaar number will be mandatory for all the students/applicants, irrespective of age. The Scholarship would be released only Aadhaar based and thus there will be no need to collect bank account details which is more time-consuming process.

The students who do not have an Aadhaar number are allowed to register through their EID numbers with the condition that all such students will obtain Aadhaar Number from the concerned authorities within 30 days and seed their Aadhaar Number into a Bar k Account. The authorities of the concerned Educational will guide and facilitate the the students in obtaining Andhaar Number in case any difficulties are faced by them.

The Head of Institution & Institution Level Nodal Officer for Schotarship will ensure that necessary verification of documents which are required as per Scheme Guidelines i.e. Caste Certificate, Income Certificate, Bonafide Certificate, Previous Year Examination Certificate /DMC, Institute Bonafide Certificate of the Students, etc.
